

PRIVACY POLICY

Some personal information is collected from and about you when you use the **Yuva Nischay (App)**. We are committed to protecting the security of this information and safeguarding your privacy. This privacy policy sets out the details of the personal information collected, the manner in which it collected, by whom as well as the purposes for which it is used. At registration you accepted the terms of this Privacy Policy and your use of the App signifies your continued acceptance thereof. This Privacy Policy may be revised from time to time and you will be notified of all such changes.

1. INFORMATION COLLECTED AND MANNER OF COLLECTION

When you register on the Yuva Nischay App, the following information is collected from you and stored securely on a server operated and managed by the Government of Bihar (**Server**) – (i) Name; (ii) Mobile Number; (iii) Email Id; (iv) Aadhar Number; (v) Father/ Mother Name; (vi) Address; (vii) Bank Details, (viii) Date of Birth, (ix) Educational Qualification, (x) Category, (xi) Co-applicant's Details (PAN, DoB, Mobile no., Aadhar no., Bank details, Address, Annual Income), (xii) Applicant's Institute Details (Institute Name, University Name, State, District, Address, Pin Code), (xiii) Applicant's Admission Date and Course Completion Date, (x) Expected monthly Income of applicant after completion of course, (xii) Course Fee (including hostel charge), (xiii) leaving expenses, (xiv) Books and Stationary, (xv) Proposed Repayment by (student/ co-applicant) (xvi) Declaration. This information will be stored on the Server and a unique Registration ID (**Reg. ID**) will be generated. The Reg. ID will thereafter be used to identify you in all transactions and will be associated with any data or information uploaded from the App to the Server.

2. USE OF INFORMATION

- a) The personal information collected from you at the time of registration under Clause (1) above, will be stored on the Server and only be used by the Government of Bihar in Database for the purpose of review/ approval/ rejection of applications, and generating reports, for the purpose of the management of Self Help Allowances (SHA), Bihar Student Credit Card (BSCC) and Kushal Yuva Program (KYP) scheme as may be required. Your Reg. Id will only be co-related with your personal information in order to communicate to you regarding your application related information.
- b) The limited personal information related to your admission in institution collected from you at the time of registration under Clause (1) above, will be used for Third Party Verification (TPVA) for authenticity of your admission, institutes bank details etc.
- c) The statistical Information/ report will be used for monitoring of scheme and further improvement in delivery of services.

d) The information collected under Clause (1) will not be used for any purpose other than those mentioned in this Clause (2).

3. RETENTION

All personal information collected from you under Clause (1) at the time of registration will be retained in existence for as long as Government of Bihar (GoB) decides.

4. RIGHTS

a) As a registered user, you have the right to access your profile at any time to modify registered mobile no. that you have provided.

b) Once you have submitted the application form, you will not have the right to add or modify any information except as mentioned under clause 4 (a).

c) You cannot manage the communications that you receive from us or how you receive them.

5. DATA SECURITY

The App is prepared with standard security features to protect the confidentiality and security of your information. Data is encrypted in transit as well as at rest. Personal information provided at the time of registration is encrypted before being uploaded to the server where it is stored in a secure server.

6. DISCLOSURES AND TRANSFER

The information collected under Clause (1) will not be used for any purpose other than those mentioned in the Clause (2) with respect to information provided to persons carrying out administrative work, monitoring of scheme necessary in relation to disposal/ verification of your application, no personal information collected by the App will be disclosed or transferred to any other third party.
